**Advice on safe handling**

Precautions should be taken to prevent the formation of dusts in concentrations above flammable, explosive or occupational exposure limits. Prevent product from entering drains. Use only with adequate ventilation. Do not breathe dust/fume/gas/mist/vapors/spray.
