Epolene C-10 polymer is supplied as free-flowing pellets, packaged in multiwall paper bags with a polyethylene coated inner liner [22.67 kg (50 lb) net weight]. The bags are palletized and stretch wrapped to prevent contamination during storage and shipment. Many Epolene polymers are also shipped in a variety of bulk containers.

#### **Storage**
