Inhalation

Section 7. Handling and storage

Precautions for safe handling

Protective measures

Put on appropriate personal protective equipment (see section 8 of SDS). Avoid exposure - obtain special instructions before use. Avoid exposure during pregnancy. Combustible dusts at sufficient concentrations can form explosive mixtures with air. High dust concentrations should be avoided. Follow US NFPA Standard 654, "Standard for the Prevention of Fire and Dust Explosions from the Manufacturing, Processing, and Handling of Combustible Particulate Solids," UK HSE Guidance HSG 103, approved Codes of Practice (ACOPS) established for Explosive Atmospheres under the ATEX Directive 1999/92/EC for worker protection and ATEX Directive 94/9/EC that regulates equipment and protection systems used in potentially explosive atmospheres or other national guidance on safe handling of combustible dusts. Train workers in the recognition and prevention of hazards associated with combustible dust in the plant.

Minimize airborne dust and eliminate all ignition sources. Keep away from heat, hot surfaces, sparks, and flame. Establish good housekeeping practices. Remove dust accumulations on a regular basis by vacuuming or gentle sweeping to avoid creating dust clouds. Use continuous suction at points of dust generation to capture and minimize the accumulation of dusts. Particular attention should be

given to overhead and hidden horizontal surfaces to minimize the probability of a "secondary" explosion. According to NFPA Standard 654, dust layers 1/32 in.(0.8 mm) thick can be sufficient to warrant immediate cleaning of the area.

Control sources of static electricity. This product or the package itself can accumulate static charges, and static discharge can be a source of ignition. Solids handling systems must be designed in accordance with applicable NFPA standards (including 654 and 77) and other national guidance. Do not empty directly into flammable solvents or in the presence of flammable vapors. The operator, the packaging container and all equipment must be grounded with electrical bonding and grounding systems. Plastic bags and plastics cannot be grounded, and antistatic bags do not completely protect against development of static charges.
