Methods and materials for containment and cleaning up	Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Take precautionary measures against static discharge. Use only non-sparking tools. Large Spills: Stop the flow of material, if this is without risk. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Large Spills: Wet down with water and dike for later disposal. Following product recovery, flush area with water. For waste disposal, see section 13 of the SDS.

7. Handling and storage

Precautions for safe handling	Eliminate all sources of ignition. Minimize dust generation and accumulation. Combustible dust clouds may be created where operations produce fine material (dust). Avoid significant deposits of material, especially on horizontal surfaces, which may become airborne and form combustible dust clouds and may contribute to secondary explosions. Handling and processing operations should be conducted in accordance with 'best practices' (e.g. NFPA-654). Provide adequate ventilation. Wear appropriate personal protective equipment. Observe good industrial hygiene practices.
Conditions for safe storage, including any incompatibilities	Keep away from heat, sparks and open flame. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Provide adequate precautions, such as electrical grounding and bonding, or inert atmospheres. Store in original tightly closed container. Store away from incompatible materials (see Section 10 of the SDS). Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces.
