5. FIREFIGHTING MEASURES

Unusual Fire and Explosion Hazards: Flash back possible over considerable distance. May form explosive mixtures in air. Exposure to combustion products may be a hazard to health. Advice for firefighters

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures: Remove all sources of ignition. Follow safe handling advice and personal protective equipment recommendations.
