#### 4. First-aid measures

<b>Inhalation</b>	Move to fresh air. Call a physician or poison control center immediately. Oxygen or artificial respiration if needed. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device.

#### 5. Fire-fighting measures

Following product recovery, flush area with water.</p> <p>Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.</p> <p>Never return spills to original containers for re-use.</p>
