Eye contact	 Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention. 		
Inhalation	: If inhaled, remove to fresh air. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Appropriate engineering controls	: Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits. Adverse symptoms may include the following:: This product contains trimethylbenzene. Literature data indicate that long-term inhalation exposure causes blood effects in laboratory animals. Adverse symptoms may include the following:: Central nervous system, liver, kidneys, and blood effects by inhalation and heart beat irregularity (arrythmia) and heart beat - increase. High exposures to xylene in some animal studies, often at levels toxic to the mother, affected embryo/fetal development. The significance of this finding to humans is not known. Xylene vapour has caused occupational skin sensitization in humans. When exposed to 1800 ppm Xylene vapor, rats experienced hearing deficits to mid-frequency range tones.
