Chemours does not intentionally use 1,4-dioxane (CAS 123-91-1) in the manufacture of Capstone<sup>™</sup> Fluorosurfactants or as an intentional component of these products. However, as a responsible supplier, we have recently taken steps to reduce the amount of 1,4-dioxane in selected grades of **Capstone<sup>™</sup> Fluorosurfactants** where this substance is known to be present as an impurity.

Based on our 1,4-dioxane reduction effort and analytical confirmation, manufacturing lots of the product grades listed below contain < 0.1% 1,4-dioxane:
